
THIS IS A BYLAW OF THE WEST INTER LAKE DISTRICT REGIONAL WATER SERVICES COMMISSION, IN THE PROVINCE OF ALBERTA, TO BE KNOWN AS THE WEST INTER LAKE DISTRICT REGIONAL WATER SERVICES COMMISSION GENERAL FEES & CHARGES BYLAW.

WHEREAS, in accordance with the *Municipal Government Act*, a local authority has the authority to establish fees and charges for the provision of goods and services;

AND WHEREAS, the West Inter Lake District Regional Water Services Commission, being a local authority in the Province of Alberta, wishes to establish, in a bylaw, certain fees and charges.

NOW THEREFORE, the Board of Directors for the West Inter Lake District Regional Water Services Commission, in the Province of Alberta, duly assembled, enacts as follows:

1. That this Bylaw may be cited as the "FEES and CHARGES BYLAW".
2. That the West Inter Lake District Regional Water Services Commission shall charge fees, charges, and penalties as established in:
 - a. Schedule A, 'General Administrative Fees and Charges,' attached;
 - b. Schedule B, 'General Operating and Service Charges,' attached;
3. Should any provision of this bylaw be invalid, then such provision shall be severed, and the remainder of the bylaw shall remain in force.
4. THAT this BYLAW shall come into force and have effect on the date of the third and final reading.
